Subject : Regarding Debarred for a period of Three years from doing
Business with Commisionerate of Health Services in Maharashtra.

The above referred Tender E-12 was published by Commisionerate of Health Services Mumbai for Printing of Flip chart, Information tool kit & Posters (7 types). The rates quoted by M/s. Jaina Offset Printers Sahibabad, Ghaziabad being lowest, were approved by the Central Purchase Committee in its meeting held on 28.04.2021.

2. Accordingly, Samples of Flip chart, Information tool kit & Posters were submitted by the firm for the proof reading & verification to the Additional Director, Health Services Pune.
3. While examining these samples, some errors were found in the flip chart sample & this was informed to firm for rectification.
4. M/s. Jaina Offset Printers has shown its inability to print the said material as per revised changes at the same quoted price stating that the paper prices have increased in market, by Email dated 05.06.2021, 15.09.21 and 19.10.2021.
5. This office instructed the firm vide letter dt. 30.11.21 to complete printing work job as per tender Condition and quoted rate, otherwise action will be taken by this office as per terms & condition of Tender Document / Govt Rules.
6. In response of this letter dated 30.11.2021 , the clarification submitted by the firm is as follows:
 - Company is not able to resubmit new samples as the paper rates are increased by 60% in the international market & also unable to execute the said job at quoted price.
 - Company is ready to print & supply 50 to 60 % quantity in all items, if department will issue the payments as quoted in the bid i.e. Rs. 18, 00,985/- + G.S.T. due to price hike in the paper market.
7. In view of the above, final Notice was issued to the firm by this office vide letter dated 12.01.2022. This office informed the firm that the clarification submitted by the firm is being rejected. No Change has been made in final specification of the tender. The tender remains valid for a period of 120 Days after the date of Opening of Envelop no.1. (Technical Bid). In the present case, the sanction letter has been issued within the prescribed period. Hence

the company should comply with the final instruction given to the firm & supply the printing materials as per Bid, Otherwise firm will be Blacklisted/ Debarred as per terms and Condition of Tender document.

8. In response to the final show-cause notice dated 12.01.2022, no reply has been received from the company till date.
9. Hence the firm M/s. Jaina Offset Printers Sahibabad, Ghaziabad has been found liable for punitive action as contained in para No. 20 of Tender Document & Govt. Resolution, Industry, Energy Labour Dept dated 1.12.2012 Clause No. 5.4 for Debarring the firm for a period of three years from doing business with Commisionerate of Health Services of Maharashtra.
10. As the Powers for Punitive actions are delegated to Commisioner of Health Services, Mumbai Vide Govt. Resolution dated 3.10.2017, hence, it is hereby ordered that M/s. Jaina Offset Printers Sahibabad, Ghaziabad be debarred for a period of three years from doing Business with Public Health Department, Govt. of Maharashtra with effect from date of issue of this order.
