If the project/program is not extended; the contract will be terminated without any notice and candidate cannot claim any right on the post or posting or cannot file any litigation regarding employment protection.
- 7. Age criteria for application are 40 years for Open category and 45 years for reserved categories. Age criteria will be relaxed by 5 years for those existing NHM employees.
- 8. All required qualifications must be of full time courses from a Government recognized and UGC approved university. Candidate should possess required minimum educational qualification on the last date of the receipt of applications. Minimum and maximum age will be as on the last date of receipt of applications.
- 9. Experience acquired after passing minimum educational qualification required for particular post will only be considered. An experience not relevant to the post will be ignored.
- 10. The experience will be relaxed if sufficient candidates are not available.
