- 1. The appointment of the selected candidate will be purely on temporary basis and for the period of 11 months, which likely to be extended if performance is satisfactory, subject to continuation of project/program. If the project/program is not extended; the contract will be terminated without any notice and candidate cannot claim any right on the post or posting or cannot file any litigation regarding employment protection.
- 2. Maximum age limit is 60 years. Age is relaxable by 5 years for retired Govt. servants and candidates holding MBBS or higher degree.
- 3. Only short listed candidates will be called for interview.
- 4. Remuneration mentioned in advertisement is consolidated. For retired State Government servants remuneration will be fixed as per GR dated 17.12.2016.
- 5. Selection of the candidates will be based upon educational qualifications, experience and

- interview or by awarding score based upon education and experience as decided by selection committee. Decision of the selection committee will be final.
- 6. All required qualifications must be of full time courses from a Government recognized university. Educational qualification from open universities will not be considered.
- 7. Candidate should possess required minimum educational qualification on the last date of the receipt of applications. Minimum & maximum age will be as on last date of receipt of applications.
- 8. The experience will be relaxed if no candidate fulfills the experience criteria. Experience acquired after passing minimum education qualification required for particular post will only be considered. Any experience not relevant to the post will not be considered.
- 9. The candidate is required to fill up and submit Small Family Declaration Form at the time of joining the post. In case it is found that the candidate is not fulfilling this norm, his candidature / appointment will be cancelled immediately.
