- 2) \$ - Mental illness means a substantial disorder of thinking ,mood,perception,orientation or memory that grossly impairs judgement ,behaviour ,capacity to recognise reality or ability to meet the ordinary demands of life , mental conditions associated with the abuse of Alcohol & drugs, but does not includes “Mental Retardation” which is a condition of arrested or incomplete development of mind of a person, specially characterised by sub normality of intelligence.

3) @ - “Care Giver” means a person who resides with a person with mental illness & is responsible for providing care to that person & includes relative or any other person who performs this function ,either free or with remuneration.
