Subject: Regarding availability and supply of Remdesivir Injection 100mg


Whereas, the Hon'ble High Court has directed that the distribution quota of the supply of the Remdesivir Injection based on the Govt., of India allocation as per reference no.5 may be intimated to all concerned. The Govt of India issued new allocation instruction for the period of 10th to 16 May 2021.

Therefore all districts are being intimated the share of Remdesivir that is their entitlement as per actives cases load on 10th April, 2021. The details of the quantity for each district are enclosed as annexure A.

All are directed to ensure that these districtwise allocations are followed and deficit, if any should be fulfilled for the stipulated duration from the remaining quantities.

All stake holders are hereby directed to follow this order as per enabling provisions of the prevailing Rules and Regulations in current pandemic situation.


