1. The result of NEET-PG 2020 was declared by NBE on 30th January 2020. In accordance with Ministry of Health & Family Welfare, Govt. of India letter F.No.V.11012/15/2020-MEP dated 14th July 2020, the minimum qualifying percentiles have been lowered as follows:
